The purpose of this job opening is to generate a roster of qualified and available candidates to fill anticipated job openings for the **Vehicle Technician (GS-4)** positions. Candidates who are successful in the assessment process will be placed on the roster. They will be notified at a later stage. Placement on the roster does not guarantee selection.

Staff members are subject to the authority of the Secretary-General and to assignment by him or her. In this context, all staff are expected to move periodically to new functions in their careers in accordance with established rules and procedures.

Organizational Setting and Reporting

These positions are located in United Nations Mission for Justice Support in Haiti, (MINUJUSTH). The United Nations' Security Council adopted resolution 2350 (2017) deciding the creation of MINUJUSTH which is mandated to assist the Government of Haiti to strengthen rule of law institutions in Haiti; further support and develop the Haitian National Police; and engage in human rights monitoring, reporting, and analysis among others.

The **Vehicle Technician (GS-4)** typically reports to the Chief of Section or Chief of Unit.

Responsibilities

These duties are generic and may vary depending on the specific position location.

- Conduct mechanical routine services and repairs of UN vehicles in accordance with vehicle manufacture standards and schedules.
- Raise, Edit and complete work orders, Damage Discrepancy report, and physical verifications both manually and electronically.
- Ensures that all relevant safety procedures have been followed when repairing and fitting replacement parts.
- Assist in maintaining an accurate spare parts inventory for all vehicles and equipment.
- Conducts vehicle inspections such as pre-summer and winter inspections on UN owned vehicles.
- Produces reports to document all servicing and repairs.
- Ability to use diagnostic tools and assists in identifying, diagnosing and rectifying of various mechanical and electronic faults.
- Assists with the identification of required parts.
- Performs any other tasks as required.

Competencies

- **Professionalism:** Shows pride in work and achievements; demonstrates professional competence and mastery of subject matter; is conscientious and efficient in meeting commitments, observing deadlines and achieving results; is motivated by professional rather than personal concerns; shows persistence when faced with difficult problems or challenges; remains calm in stressful situations. Takes responsibility for incorporating gender perspectives and ensuring the equal participation of women and men in all areas of work.
- **Teamwork**: Works collaboratively with colleagues to achieve organizational goals; Solicits input by genuinely valuing others' ideas and expertise; is willing to learn from others; Places team agenda before personal agenda; Supports and acts in accordance with final group decision, even when such decisions may not entirely reflect own position; Shares credit for team accomplishments and accepts joint responsibility for team shortcomings.
- Client Orientation: Considers all those to whom services are provided to be "clients" and seeks to see things from clients' point of view; establishes and maintains productive partnerships with clients by gaining their trust and respect; identifies clients' needs and matches them to appropriate solutions; monitors ongoing developments inside and outside the clients' environment to keep informed and anticipate problems; keeps clients informed of progress or setbacks in projects; meets timeline for delivery of products or services to client.

Education

High school diploma or equivalent is required. Institute certificate for Motor vehicle mechanic. Valid driving license.

Work Experience

At least three (03) years of professional experience in transport operations management, including UN field experience.

Languages

English and French are the working languages of the United Nations. For the post advertised, fluency in oral and written English or French, both oral and written, is required. Working knowledge of the other language is desirable.

Assessment

Evaluation of qualified candidates may include an assessment exercise which may be followed by competency-based interview.
